This model is a practical tool to implement tap water options at events. The criteria and example measures are cumulative. It is aligned with the European Circular Festivals Model and Dutch Duurzaamheidsladder Evenementen (DLE), which both strive for circular and climate-neutral events.

Tap water at clubs and festivals

Reduce your environmental impact and serve tap water at your club or event.



Measures to become Circular on tap water:

- All materials used are derived from renewable sources, such as biobased or recycled materials, eliminating the reliance on fossil fuels and other scarce natural resources.
- The use of single-use plastics is eliminated, with any avoidable plastic being recycled to a high standard.
- Avoid the use of water from non-main supplies and in packaging wherever possible and safe.
- All unavoidable emissions from transport, heating and cooling, are balanced.

- Drinking quality tap water is available at refill / hand wash stations.
- Sufficient tap water is available according to the heat protocol.
- Performed according to the local regulations for drinking water installations and
 the connection conditions of the water supply company.

Example of measures

- The water is local, or if not available from a short supply chain within 200 km of the event.
- Use water-saving taps and regularly check on water leakage to reduce the spillage of water.

Criteria

- Allow visitors to bring an empty reusable bottle.
- Ensure no restrictions on bottle material types unless justified by safety protocols.

Example of measures

- Water tap stations at the event.
- Stimulate use of reusable water bottles by artists, crew and suppliers.
- Provide clear guidance on the event website (FAQ) about the policy for bringing reusable bottles.
- Communication about free tap water stations on the event map and signage.

- No sales of packaged water, only provide tap water for sale or for free.
- Sell reusable water bottles filled with (cooled) tapwater.
- Offer cooled, filtered and/or flavored tap water.
- Create a visible and user-friendly mobile app or map showing water station locations.
